QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of Nelson County, Virginia under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia participate in this Mass Meeting, subject to the provisions in Article I of the Plan of Organization.

Mass Meeting participants must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate.

A voluntary fee of \$20.00 is requested for participants in this Mass Meeting.

CHAIRMAN FILING REQUIREMENTS

Candidates for election as Chairman of the Nelson County Republican Committee must file the completed and signed Declaration of Candidacy form attached to this call by **2:00 PM, February 13, 2026**, and shall include a check or evidence of payment of a **\$100.00** (one hundred dollar) filing fee.
