As Chairman of the Campbell County Republican Committee of the Republican Party of Virginia and pursuant to the Plan of Organization and as recommended and directed by the Unit Committee, I, Katherine Decker, do hereby issue this Call for a Mass Meeting to be held at Harberer Room or its alternate site, starting at 10:00AM, with registration beginning at 9:00PM, on March 14 for the following purposes:

- a) Electing a Unit Chair;
- b) Electing up to 785 Members of the Unit Committee At Large.

and for the transaction of such other business as may properly come before the convention.

### Qualifications for Participation

All citizens of the United States who are legal and qualified voters of the Campbell County Republican Committee under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

### Candidate Filing Requirements

Candidates for Chair must declare their candidacy in writing using the attached official pre-filing form, accompanied by a non-refundable filing fee of \$150.00, which must be received no later than 5:00PM on March 6th.

Candidates for two-year term voting membership in the Campbell County Republican Committee must submit their pre-filing form, accompanied by \$30 dues.

Submission of the pre-filing form and fee/dues may be either mailed to CCRC PO Box 1213 Rustburg, VA 24588; hand-delivered to the Chairwoman Katherine Decker, or dropped off between 3:00PM-5:00PM on March 6<sup>th</sup> at 1600 Bethany Rd. Rustburg, Virginia. Checks must be made payable to "Campbell County Republican Committee."

### Cancellation Provisions

If the number of persons filing as candidates for election or nomination does not exceed the number to be elected or nominated for a particular office, those persons shall be declared elected or nominated.

If the number of persons filing as candidates for election or nomination for all offices does not exceed the number to be elected or nominated, the Mass Meeting will be cancelled.

### NOTE: PUBLICATION/DISTRIBUTION REQUIREMENTS

#### Timing—

1. A Call may not be published prior to January 1.
2. A Call may not be published more than 60 days prior to the mass meeting
3. A Call may not be published prior to the approval of the terms of call for any convention to which delegates will be elected.
4. A Call must be published not less than 7 days prior to any pre-filing deadline
5. A Call must be published not less than 7 days prior to the mass meeting (15 days in a Presidential election year)

Distribution—the Call and any pre-file forms must be published as follows:

1. RPV Website
2. Unit and District Websites, if available and appropriate
3. E-mail to all members
4. E-mail to district chair(s)
5. “use the most effective means available, including news media, to adequately publicize Mass Meetings ... with the purpose of encouraging maximum citizen involvement”
