____ I have participated in the nominating process of another party in the last five years, but I renounce affiliation with any party other than the Republican Party, intend to support the nominees of the Republican Party in the future and understand that the Campbell County Republican Committee shall provide a copy of this signed renunciation statement to the Republican Party of Virginia, to be maintained for a period of 5 years, and shall also keep a copy in its own permanent records.

This form may be physically mailed to CCRC, Attn: Membership PO Box 1213, Rustburg, VA 24588, hand-delivered to the chairman, or dropped off between 3:00PM-5:00PM on March 6th at 1600 Bethany Rd. Rustburg. This form and fee/dues must be received no later than 5:00PM March 6th.

*Note: The State Party Plan of the Republican Party of Virginia does allow a voter who participated in another party's nomination process in the past five years to renounce affiliation with any other party in writing, and express in writing that he/she is in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future. People wishing to renounce their affiliations with other parties MUST complete a written renunciation, which will be subject to public scrutiny at the next meeting of the Campbell County Republican Committee. In accordance with the State Party Plan, Committee Members may choose to elect or reject any person seeking election to the Committee. Written renunciations will become part of the permanent public records of the Republican Party. A second violation of the above oath is a lifetime disqualification from participation in Republican Party functions.
