

## **Danville Republican Committee Canvass**

As Chair of the Danville Republican Committee pursuant to the Republican Party Plan of Organization and as recommended and directed by the Committee, I, Betsy Young, do hereby issue this **Call for a Canvass (Firehouse Primary)** to be held at Wilkins and Company, [428 Piney Forest Road, Danville, VA 24540](#), or an alternate site if necessary, at 6:00 PM on Tuesday, April 28 for the following purposes:

### **A. Electing members of the Danville Republican Committee**

### **B. Election of the executive positions: Chairman, Vice Chairman, Secretary and Treasurer**

#### **Qualifications for Participation**

All legal and qualified voters of Danville under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts..

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from March 1, 2021. A single exception to this restriction shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intend to support the nominees of the Republican Party in the future.

#### **Conduct of the Canvass**

The **Firehouse Primary** will be conducted on Tuesday, April 28 from 6:00 PM to 7:00 PM. Rules for the conduct of the canvass will be promulgated by the Danville Republican Committee. Voters offering to vote must be properly registered in Danville, must present a government -issued photographic identification document. They also must sign a statement of intent to support the Republican Party's candidates in the General Election on November 3, 2026. Individuals who do not meet these requirements will not be allowed to participate.

#### **Danville Republican Committee Membership**

Candidates for committee membership at said **Firehouse Primary** shall pre-file the application for membership to the Danville Republican Committee beginning March 24, 2026, and ending April 15, 2026, at 4:00 PM. Completed applications along with membership dues of \$10.00 are to be mailed or hand delivered to Betsy Young at [625 Piney Forest Road, Suite 402, Danville, VA 24540](#). Checks need to be made out to the **Danville Republican Committee**. Postmarks do not govern, and it is the responsibility of the prospective member to confirm receipt of application and dues. The membership application is presented below this **Call**.

## **Danville Republican Committee Executive Position Filing Requirements**

Candidates for Unit Chairman, Vice Chairman, Secretary and Treasurer at said firehouse primary must file a written statement by mail or in person only, declaring intent to run to

### **Resolutions**

Resolutions shall not be considered at this firehouse primary.

### **Registration Fee**

There will be no registration fee to participate in this firehouse primary.

### **Cancellation Notification**

Should no more than one candidate properly file for each executive position, then such candidate shall be duly elected to their respective position. Should no more than one candidate file for Chairman, Vice-Chairman, Secretary and Treasurer, those candidates shall be elected, and the firehouse primary shall be cancelled and replaced with a regular meeting of the Danville Republican Committee.
