

**OFFICIAL CALL
Mass Meeting
of Appomattox County
of the Republican Party of Virginia**

As Chairman of the Appomattox County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Craig Scott, do hereby issue this call for a Mass Meeting to be held at **the Appomattox Community Center, 220 Community Lane, Appomattox, VA 24522** or alternative site as determined by the Chairman, starting at **6pm** local time on **Tuesday, September 22** for the following purposes: Electing up to 255 Delegates and an equal number of Alternates to the Fifth District Convention, to be held on November 14, 2026 beginning at 10:00 AM at the Thomas Gymnasium at Fork Union Military Academy, 4744 James Madison Highway, Fork Union, VA 23055 for the purpose of electing a Fifth District Chair. b) and for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Appomattox County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from March 1, 2021.

A single exception to this restriction shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

Fifth District Republican Conventions Delegate Filing Requirements

Delegate candidates for election at said mass meeting shall pre-file a separate application for the Virginia and/or Fifth District Republican Conventions along with the mandatory delegate filing fees by **Friday, September 11, 2026 at 5:00 PM deadline**.

Completed applications and delegate filing fees are to be **dropped off in person to secured outside lock box at Chase-Scott Business office, 2023 Church Street, Appomattox, VA 24522 or by appointment by calling Amanda at 804 370 8727. Or mail to Craig Scott, PO Box 374, Appomattox, VA 24522**. Postmarks do not govern, and it is the responsibility of the delegate to confirm receipt of application with the Chair. Available email to verify the delivery of application is **craigmfree@gmail.com**.

The delegate application form for the Fifth District Republican Convention is attached to this call. The Fifth Congressional District Republican Committee is requiring a \$20 filing fee from all individuals seeking election as a delegate or alternate delegate to the Fifth Congressional District Republican Convention. A separate check needs to be made out to the "Appomattox Republican Committee". Cash can be accepted.

Resolutions: Resolutions shall not be considered at this Appomattox GOP Mass Meeting.

Registration Fee: There will be NO registration fee to participate in the Appomattox County GOP Mass Meeting.

Cancellation Notification: Should no more than 255 delegates pre-file for the Fifth District Republican Convention by the deadline, then those candidates shall be duly elected by acclamation, and the mass meeting shall be cancelled.
