Mecklenburg County Republican Committee (MCRC) Mass Meeting Of the Republican Party of Virginia

As Chairman of the Mecklenburg County Republican Committee (MCRC), and pursuant to the Plan of Organization and as recommended and directed by the County Committee, I, R. Wallace Hudson, Chairman, do hereby issue this call for a Mass Meeting to be held at the New Hope Baptist Church Fellowship Hall located at 255 Union Mill Road, LaCrosse, VA 23950 starting at 7:00 PM local time on Tuesday, September 8, 2026 for the purpose of:

- 1) Elect up to 335 Delegates and an equal number of alternates to the 5th District Convention. The MCRC has 67 votes. The 5th District Convention will be held on November 14, 2026 in Fluvanna County at 10:00 AM at:

Qualifications for Participation

All legal and qualified voters of the County of Mecklenburg under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions or primaries encompassing their respective election districts.
