

**OFFICIAL CALL**  
**Mass Meeting**  
**Amelia County Republican Committee**  
**of the Republican Party of Virginia**

As Unit Chair of the Amelia County Republican Committee, and pursuant to the Plan of Organization of the Republican Party of Virginia, and as recommended and directed by the Committee, I, J. Phillip Amiss, do hereby issue this call for a Mass Meeting to be held at The Amelia County Administration Building, 16360 Dunn St., Amelia, VA 23002 starting at 7:00 ET on September 30, 2026 for the following purposes:

1. Electing as many as 190 delegates and an equal number of alternates to the Fifth District Republican Party Convention to be held:

Saturday, November 14, 2026 at 10:00 AM

Thomas Gymnasium at Fork Union Military Academy

4744 James Madison Highway, Fork Union, VA 23055

OR

An alternate site if necessary for the following purposes:

- a) Election of Fifth District Republican Committee Chairman
- b) Transaction of such other business as may properly come before the Convention

**Qualifications for Participation**

All legal and qualified voters of Amelia County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as a member of the Republican Party of Virginia in this Mass Meeting.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from March 1, 2021. A single exception to this restriction shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

### **Participant Check-in**

Check in will begin at 6:00 PM ET and will conclude at 7:00 PM ET. All participants in line at 7:00 PM ET will be allowed to check in. The Mass Meeting shall be called to order at 7:00 PM ET or upon completion of participant check in.

### **Registration Fee**

There will be no registration fee to participate in the Mass Meeting.

### **Pre-Filing Requirements**

Individuals may file as an Amelia County Republican Committee Delegate or Alternate to the Fifth District Republican Party Convention using the official form included with this Call.

**All forms submitted to the unit must be signed by the prospective Delegate.**

Pre-filed Delegate forms will be accepted in person, and by U.S. Postal mail no later than 5 PM, September 21, 2026. Pre-filed Delegate forms submitted by U.S. Postal Mail are to be mailed to Martha Muniz, P.O. Box 101 Amelia, VA 23002. Pre-filed forms submitted in person may be delivered to Martha Muniz. Contact her by texting or calling at 804-814-4969 to arrange delivery. Postmarks will not govern and it is the responsibility of prospective delegates to confirm that their forms have been received.

Delegates and Alternates to the convention must pay a mandatory fee of \$20. Checks for the mandatory fee should be made payable to the Amelia County Republican Committee and are to accompany the pre-filed Delegate form.

### **Military Members as Delegates**

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H, para 6. of the Plan of Organization of the Republican Party of Virginia.

Military Member Delegates or Alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia.

### **Resolutions**

No resolutions will be considered.

### **Meeting Cancellation**

In the event filings for committee Delegates and Alternates to the convention do not exceed the specified limits, the meeting shall be cancelled.

### **Publication**

This Call shall be posted on the website of the Republican Party of Virginia (<https://virginia.gop/events/category/official-call/>) and on the Fifth Congressional District Republican Committee (<http://www.5thdistrictva.gop/District-Convention.>)

### **Call Revisions**

The Executive Committee of the Amelia County Republican Committee is authorized to revise the issued Call to make any such technical or conforming changes in the event such changes are necessary. Executive Committee must promptly notify the Cumberland County Republican Committee of any such technical or conforming changes.
