

Campbell County Republican Committee Party Canvas

As Chairman of the Campbell County Republican Committee pursuant to the Republican Party Plan of Organization and as recommended and directed by the Committee, I, Sarah Lawson, do hereby issue this call for a Party Canvas to be held at Rustburg Public Library, 684 Village Hwy, Rustburg, VA 24588, or an alternative site as determined by the Chairman, from 10:00am to 2:00pm on Saturday, September 19, 2026.

The purpose of this party canvas is electing up to 785 Delegates and an equal number of Alternate Delegates to the Fifth Congressional District Republican Convention, to be held on Saturday, November 14 at the Fork Union Military Academy, 4744 James Madison Hwy, Fork Union, VA 23055, or an alternate site, if necessary, for the purpose of electing a District Committee Chair.

Qualifications for Participation

All legal and qualified voters of Campbell County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from March 1, 2021. A single exception to this restriction shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

Fifth District Republican Conventions Delegate Filing Requirements

Delegate candidates for election at said party canvass shall pre-file an application for the Fifth District Republican Convention along with the mandatory delegate filing fees by September 11, 2026 at 5:00 PM. Completed application and delegate filing fees are to be mailed to Sarah Lawson at P.O. Box 1213, Rustburg, VA 24588 or hand delivered to 1600 Bethany Rd, Rustburg, VA 24588. Postmarks do not govern, and it is the responsibility of the delegate to confirm receipt of application with the Chair. Available email to verify the delivery of application is

campbellctygopchair@gmail.com. The delegate application form for the Fifth District Republican Convention is attached to this call.

The Fifth Congressional District Republican Committee is requiring a \$20 filing fee from all individuals seeking election as a delegate or alternate delegate to the Fifth Congressional District Republican Convention. A separate check needs to be made out to the “Campbell County Republican Committee”. Cash can be accepted.

Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) may be certified as delegates by complying with the procedures detailed in a Unit’s call pursuant to Art. VIII, Sec. H, para. 6. Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots.

Resolutions

Resolutions shall not be considered at this Party Canvas.

Registration Fee

There will be NO registration fee to participate in this Party Canvas.

Cancellation Notification

Should no more than 785 delegates pre-file for the Fifth District Republican Convention by the deadline, then those candidates shall be duly elected by acclamation, and the party canvas shall be cancelled.
