

Charlotte County Republican Committee Party Mass Meeting

As Chairman of the Charlotte County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Noah J. Davis, do hereby issue this call for a Mass Meeting to be held at The Drakes Branch Fire Department, 4801 Drakes Main Street, Drakes Branch VA, or an alternate site, if necessary, at 7:00 PM on Thursday, September 10th for the following purposes:

- A. Electing up to 140 Delegates and an equal number of Alternate Delegates to the Fifth Congressional District Republican Convention, to be held on Saturday, November 14th, 10AM in the Thomas Gymnasium at The Fork Union Military Academy located at 4744 James Madison Hwy, Fork Union, VA 23055, or an alternate site if necessary for the following purpose.

- 1) Election of a District Committee Chair
- 2) Transaction of such other business as may properly come before the Convention

Qualifications for Participation

All legal and qualified voters of Charlotte County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party, nor supported a candidate against a Republican Nominee in the last five years from September 1, 2021. A single exception to this restriction shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

Fifth District Republican Convention Delegate Filing Requirements

Delegate candidates for election at said mass meeting shall pre-file a separate application for the Fifth District Republican Convention beginning August 13, 2026, and ending September 10th, 2026, at 7:00 PM. Completed applications are to be hand delivered or mailed to Noah Davis, Chairman, PO Box 2, Drakes Branch VA 23937. It is the responsibility of the delegate to confirm receipt of application with the Chair. Postmarks do not govern. The application for the Fifth District Republican Convention is attached to this call.

Required Filing Fees

The Fifth Congressional District Republican Committee is requiring a \$20 filing fee from all individuals seeking election as a Delegate to the Fifth Congressional District Convention. Checks will need to be made out to the "Charlotte County Republican Committee". All filing fees may be attached to the completed delegate filing form.

Cancellation Notification

Should fewer than 140 delegates pre-file for the Fifth District Republican Convention, the Mass meeting will be canceled and those candidates for delegate shall be duly elected by acclamation.
