**Official Call Mass Meeting of
The Danville City Republican
Committee of the Republican
Party of Virginia**

Issued September 15, 2026

As Chairman of the Danville City Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Betsy Young, do hereby issue this call for a Mass Meeting to be held at the Comfort Inn & Suites [100 Tower Drive Danville, VA 24540](#), or an alternative site as determined by the Chairman, starting at 6:30 p.m. local time on Saturday, September 26, 2026, for the following purposes:

- a) Electing up to 230 Delegates and 230 Alternates to the Fifth District Convention, to be held on November 14, 2026, beginning at 10:00 a.m. at the Thomas Gymnasium at Fork Union Military Academy, [4744 James Madison Highway, Fork Union, VA 23055](#), for the purpose of electing a Fifth District Chair.
- b) for the transaction of such other business as may properly come before the Party Mass meeting/Canvass.

Qualifications for Participation

All legal and qualified voters of Danville City, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from March 1, 2021. A single exception to this restriction shall be approved for a voter that renounces affiliation with any other

party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

Filing Requirements

Candidates for election as Delegate or Alternate at said Mass Meeting shall file the attached, completed and signed Delegate Filing Form by mail or in person to Betsy Young at [106 Oakwood Circle Apt. A Danville, VA, 24541](#) or at the Danville-Pittsylvania County GOP Headquarters at [625 Piney Forest Road, Suite 402](#) A, Danville, VA 24540. Delegate forms must be received no later than Thursday, September 24, 2026, 5:00 p.m. Postmarks do not govern, and it is the responsibility of the delegate to confirm receipt of application with the Chair. The Delegate Filing Form is attached to this call and may also be obtained by emailing DanvilleRepubChair@gmail.com.

The Fifth Congressional District Republican Committee is requiring a \$20.00 filing fee from all individuals seeking election as a delegate or alternate delegate to the Fifth Congressional District Republican Convention. A separate check needs to be made out to the “Danville Republican Committee”. Cash can be accepted.

Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) may be certified as delegates by complying with the procedures detailed in a Unit’s call pursuant to Art. VIII, Sec. H, para. 6. Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots.

Registration Fee

There will be NO registration fee to participate in the Party Mass meeting.

Cancellation

Should no more than 230 delegates pre-file by the deadline, then those candidates shall be duly elected by acclamation, and the mass meeting shall be cancelled.
