

Lynchburg Republican City Committee Mass Meeting

As Chairman of the Lynchburg Republican City Committee pursuant to the Republican Party Plan of Organization and as recommended and directed by the Committee, I, Zach Melder, do hereby issue this call for a Mass Meeting to be held at 819 Main St. Lynchburg VA 24504, or an alternative site as determined by the Chairman, starting at 10 a.m. local time or soon thereafter as is practicable on September 26, 2026. Registration begins at 9 a.m.

The purpose of this mass meeting is electing up to 610 Delegates and an equal number of Alternate Delegates to the Fifth Congressional District Republican Convention, to be held on Saturday, November 14 at the Thomas Gymnasium at Fork Union Military Academy at 4744 James Madison Highway, Fork Union, VA 23055 or an alternate site, if necessary, for the purpose of electing a District Committee Chair and for the transaction of such other business as may properly come before the Convention.

Qualifications for Participation

All legal and qualified voters of Lynchburg City under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from September 26, 2021. A single exception to this restriction shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

Fifth District Republican Conventions Delegate Filing Requirements

The Fifth Congressional District Republican Committee is requiring a \$20.00 filing fee from all individuals seeking election as a delegate or alternate delegate to the Fifth Congressional District Republican Convention. A separate check needs to be made out to the “**Lynchburg Republican City Committee.**” Cash can be accepted.

Delegate candidates for election at said mass meeting shall pre-file a separate application for the Fifth District Republican Convention along with the mandatory \$20.00 delegate filing fees by 5:00 p.m. September 18, 2026. Completed applications and delegate filing fees are to be mailed, emailed, or hand delivered to 1313A Enterprise Dr. Lynchburg VA 24502. Postmarks do not govern, and it is the responsibility of the delegate to confirm receipt of application with the Chair. Available email to verify the delivery of application is lynchburggopcommittee@gmail.com. The delegate application form for the Fifth District Republican Convention is attached to this call.

Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) may be certified as delegates by complying with the procedures detailed in a Unit's call pursuant to Art. VIII, Sec. H, para. 6 of the Party Plan of the Republican Party of Virginia. Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots.

Registration Fee

There will be no registration fee to participate in this Mass Meeting.

Cancellation Notification

Should no more than 610 delegates pre-file by the deadline, then those candidates shall be duly elected, and the mass meeting shall be cancelled.
